



## CALL OUT FOR ARTISTS

### CLBC Indigenous Advisory Committee Logo

Community Living BC (CLBC) is looking for artists interested in working with the Indigenous Advisory Committee to collaborate on the creation of a logo to represent their work. The artist must be willing to meet with the committee, CLBC and the community to collaborate on the creation of the logo.

CLBC is the provincial government crown corporation that funds supports and services to adults with developmental disabilities, as well as individuals who have a diagnosis of Autism Spectrum Disorder or Fetal Alcohol Spectrum Disorder.

CLBC believes we have a collective responsibility as citizens to enhance our communities so that everyone belongs. Our vision is for everyone in British Columbia to experience “communities of belonging, and lives with connection” for individuals with developmental disabilities and their families residing within British Columbia’s urban, rural, status and non-status First Nations, Métis, and Inuit communities. The Advisory Committee supports the mandate of CLBC through the provision of information and guidance to CLBC staff, within an Indigenous perspective and worldview.

As part of the process of reconciliation CLBC and the Indigenous Advisory Committee (IAC) would like to identify and artist to collaborate and create a logo representative of the vision and mandate of Indigenous community inclusion that will work in tandem and complement with CLBC’s existing visual identity.

#### **Eligibility**

This artist call is open to professional or accomplished Indigenous visual artists, preference will be given to an artist experienced in graphic consultation. The Indigenous Advisory Committee requires that the logo artwork be digital or flat surface art and that CLBC be given the rights to reproduce and use in any and all representation of CLBC and the IAC Committee.

All artwork(s) must:

- Be unique, original, and made by the artist(s) in collaboration with the IAC and CLBC.
- Be created with diverse and inclusive visual representation of IAC mandate.
- Be capable of reproduction.

#### **Compensation**

The artists chosen to deliver final designs will receive compensation based on above fair market value upon fulfilling and releasing all rights to the final work. The artist chosen will be compensated with wages and expenses covered (travel etc. if required) for time put into consulting with the IAC.

#### **Project Timeline and Requirements**

The IAC will be reviewing interested artists at the next gathering in December. Deadline for submissions is December 9<sup>th</sup> 2022. Entries must be submitted through email and include the following: Artist biography or summary of experience; Full contact information; digital image files of previous works and/or online links. Explanation of interest in logo creation, approach to collaboration with CLBC and compensation expectations. All work must be completed and released by June 21st, 2023.
